D. Greenhill Bridge Replacement NHDOT Bid Award

- i. The Greenhill Bridge replacement project was advertised in late 2022 and the Town received two proposals.
 - 1. Cold River Bridges, LLC \$2,137,137.50
 - 2. CPM Constructors, Inc. \$2,487,057.50
- ii. As an NHDOT State Bridge Aid project, 80% funding comes from the State. The State has authorized proceeding with the low bidder, Cold River Bridges.
- iii. In 2020, the Town established a Greenhill Bridge replacement non-lapsing account with \$400,000. The remainder of the Town's 20% will come from the Bridge and Culvert Capital Reserve.
- iv. The construction schedule would be:
 - 1. April 3, 2023 Contractor Takes Site
 - 2. June 12, 2023 Close Bridge to Traffic
 - 3. October 10, 2023 Open Bridge to Traffic
 - 4. October 27, 2023 Substantial Completion
 - 5. November 17, 2023 Final Completion

Make a motion to award the Greenhill Bridge replacement project to Cold River Bridges for \$2,137,137.50 and to appropriate up to \$400,000 from the Greenhill Bridge Non-Lapsing account and up to \$50,000 from the Bridge and Culvert Capital Reserve.

- H. Plowing Conservation Parking Areas
 - i. There has been a request to have the Highway Department (as time and equipment allows) plow the Conservation parking lots.

 - iii. In 2019, the Select Board adopted a Highway Billing Policy which would require that the Conservation Commission pay the Town (from the Conservation Fund) for the Highway Department services. The rate would be 140% of staff time plus FEMA equipment rates.
 - iv. I have discussed the proposal with the Road Agent, and he feels that he would have the staff and equipment to clear the parking areas following storms. It would be important to keep in mind that this would not happen until the day(s) following a storm and the Road Agent would not utilize overtime to accomplish the task.

9. Old Business

10. New Business

- A. 2023 Warrant Information Postcard Discussion
 - i. A voter guide was suggested in discussion with Department Heads and residents regarding informing voters of the topics to be decided at Town Meeting. Over the past few years, we have created a webpage to organize the objective information about articles on the warrant. It was discussed that many residents are unaware of the www.barrington.nh.gov/2023warrant webpage and others do not seek or access that information online.
 - ii. In lieu of mailing a physical copy of a voter guide to all residents, it was suggested that every door direct mail could be used to mail voters a postcard. The card could inform residents of the March 14th vote (with a few highlights) and could direct residents to an online voter guide. There could also be a note that physical copies of the voter guide could be obtained from the Town Hall, Library, etc.
 - iii. The town mailed a 6.5" x 9" postcard to voters in 2019 ahead of the Town Hall vote. This cost the Town \$1,599 for 4,025 addresses. A cost increase is likely, but this gives an idea of the approximate cost.
 - iv. If the Select Board were interested, I would propose scheduling a postcard to hit mailboxes approximately two weeks prior to the Town Meeting vote. This outreach effort would obviously occur in tandem with additional efforts to inform voters ahead of voting day.
 - v. The Select Board is asked to consider the proposal to mail informative postcards to residents ahead of the March 14th Town Meeting vote.
- B. Road Naming Request Gooseneck Lane to Sergeant Way Discussion
 - i. The Town recently received a request to consider changing the name of Gooseneck Lane to Sergeant Way in honor of Jesse Sherrill. Pursuant to RSA 231:133, the Select Board may approve road name changes.
 - ii. The name of Sergeant Way was considered for conflicts by the Road Naming Committee and E911. There were no conflicts.

- iii. There are 18 properties with addresses on Gooseneck Lane, including Jesse Sherrill's family. The road name change would require each of those property addresses to change.
- iv. If the Select Board further considers this request, it is recommended that a letter be sent to each property owner on Gooseneck Lane describing the proposed name change and inviting them to anonymously support or object to the proposal.
- v. The Select Board is asked to consider how to proceed.

C. School Demographic Study Cost Share – Discussion

- i. At a recent School Board meeting they discussed the completion of a demography study. The School Board voted to complete this study at a cost of \$6,520. The question was raised regarding whether the Town would consider sharing this cost as the information gathered may also be beneficial to the Town's planning.

D. Speed Limit Reduction Request - Mica Point - Discussion

- iii. Pursuant to <u>RSA 265:63</u>, the Select Board may alter speed limits on Town roads, following an engineering or traffic investigation. The statute does not allow the speed limit to be reduced below 25 miles per hour.
- iv. The Select Board is asked to consider proceeding with a traffic study on Mica Point Road for the purpose of a requested speed limit reduction.

E. Transfer Station Trash Bag Price Increase – Vote

- i. The Transfer Station and Recycling Center Review Committee has been evaluating the rising costs of municipal solid waste (transportation and disposal) and the Town's <u>pay-as-you-throw</u> model. The price for residents to purchase trash bags has not changed since 1998!

Public Comment

Meetings are open to the public, but public participation is limited. If you wish to be heard by the Select Board, please note the two Public Comment portions of the meeting to speak to items on a meeting agenda and/or matters pertaining to the business of the Select Board. In addition, public hearings may be scheduled for public comment on specific matters. Speakers must be residents of the Town of Barrington, property owners in the Town of Barrington, and/or designated representatives of recognized civic organizations or businesses located in the Town of Barrington. When they are addressed and permitted to speak by the Chair, speakers first need to recite their name and address for the record. Visitors should address their comments to the Chair and the Select Board as a body and not to any individual member. Each speaker shall be provided a single opportunity for comment, limited to three (3) minutes. Public Comment shall be limited to fifteen (15) minutes. Visitors should not expect a response to their comments or questions since the Select Board may not have discussed or taken a position on a matter. Public Comment is not a two-way dialogue between speaker(s), Select Board, and/or the Town Administrator. The Chair will preserve strict order and decorum at all Select Board meetings. Obscene, violent, disruptive, disorderly comments, or those likely to induce violence, disruption, or disorder, are not permitted and will not be tolerated. Complaints regarding Town staff should be directed to the Town Administrator.

Nonpublic Session

The Select Board may enter one or multiple nonpublic sessions pursuant to RSA 91-A:3, II. The public is not permitted to attend nonpublic sessions and will be asked to leave the meeting space. Nonpublic sessions are allowed for reasons including: Dismissal, promotion, compensation, disciplining, investigation or hiring of a public employee; Matters which would likely adversely affect the reputation of any non-board member; Buying, selling or leasing real or personal property if public discussion would give someone an unfair advantage over the municipality; Lawsuits filed or threatened in writing against the municipality, until fully adjudicated or settled; and Preparation for and carrying out of emergency functions related to terrorism.
