CALL TO ORDER

Barrington Conservation Commission (BCC) Vice-chair Pam Failing called the meeting of July 11, 2019, to order at 6:34.

DELEGATION OF VOTING MEMBERS Vice-chair Pam Failing confirmed the presence of members as above, with Marika serving as a voting member.

Guests: James Hayden from Berry Surveying in regards to minimum expedited wetland permits for the proposed development off Meetinghouse Road. There are two pockets of wetlands impacted with a total of 2,800sf. CC members reviewed the map, and **John Wallace made a motion that the CC approve the wetlands permit applications. Anne Melvin seconded the motion, which passed unanimously with a vote of five (5) to zero (0) in favor.** Pam signed the permits.

Sightings: A doe with fawns, a rabbit, and Baltimore orioles were reported. Traveling out of Barrington, Doug sighted Black Storks and European Bison (Poland) and kites (England).

Approval of minutes for June 20, 2019 John Wallace made a motion to accept the minutes of June 20. Anne Melvin seconded the motion, which passed unanimously with a vote of five (5) to zero (0) in favor.

Treasurer's Report (Anne) (only available balance for Conservation Commission use) It was noted that \$2500 from was received from the Lamprey River Advisory Committee for use toward the NRI/co-occurrence mapping. Anne reported the updated amount in the Conservation Fund is \$295,210.58.

Old Business – Richardson Bridge, Haley/Panish/Rubinstein project

John stated the agreement for language for the Panish easement is settled. This will need to go before the Selectboard for the purchase and sales agreement. The land will be placed in conservation easement and a small area will be provided for parking.
