CALL TO ORDER

Barrington Conservation Commission (BCC) Chair John Wallace called the meeting of September 6, 2018 to order at 6:30.

DELEGATION OF VOTING MEMBERS Chair John Wallace confirmed the presence of members as above.

- 1) Sightings included a plethora of squirrels, mallards eating bird seed, monarch caterpillars, and spicebush swallowtails.
- 2) Guests: Charlie Briggs, a CC member to be. Peter Nourse, (Rochester Public Works) Tracy Tarr (GZA Geo Environmental, Inc.) Mr. Norse gave an overview of the proposed changes to the water level at Round Pond and the reasons for raising its average annual level. He stated that about ³/₄ of the shoreline is Rochester property, and the water comes from Strafford and Farmington. The State has asked for a minimum 2 cubic feet per second stream flow in Berry River for the ecological health of the river, but Mr. Norse anticipates that the 2 cfs minimum will be increased by the implementation of instream flow rules. Raising the level of Round Pond 8 feet by taking more water in the winter and spring would allow for a steadier flow in the Berry River and Isinglass during the summer months; during drought this plan could help Rochester meet its water needs while lessening the impact on Berry River and the Isinglass. Tracy Tarr presented the results of the study done to determine the ecological impact to Round Pond and the surrounding area. It was noted that Blending's turtles were found, and the project is designed for the protection of the turtles. Tracy stated that the open water area would go from 94.47 acres to 112.72, and this would lead to either gaining or maintaining the aquatic bed, which is nice for wildlife diversity. This project would include mitigation for the dam work and vernal pools and scrub shrub and emergent wetlands impacted. Tracy will look into the amount allowed for mitigation. John asked about the dam being on the Whitecrest easement and noted that the easement language will have to be checked regarding this. The CC had a favorable response to the plan as presented.
- 3) Complaints: Dan mentioned shooting at the Newsky property.
- 4) Approval of minutes of August 16 Doug Bogen made motion to approve the minutes of August 16 as amended. Marika Wilde seconded the motion, which passed unanimously with a vote of three (3) to zero (0) in favor.

Doug Bogen seconded the motion, which passed unanimously with a vote of three (3) to zero (0) in favor.
 - d) PB: Results of meeting about Goodwill Driveway/Parking area; The PB reviewed the proposal and did not have concerns, but suggested brush be cleared for better visibility. Hard Rock proposal continued to Oct.; proposal forthcoming for subdivision on Old Greenhill Rd.
