
We are pleased to submit our formal application and plans for the Ramsdell Woods subdivision. The plans for Ramsdell Woods contemplate a single-family subdivision utilizing Article 6 - Conservation Subdivision requirements of the Barrington Zoning Ordinance. The yield plan for the application, submitted as a component of the plan set, has received initial favorable review from the Land Use Department. The Yield Plan supports 15 lots under a conventional design. In the Neighborhood Residential zone the density is limited to 20% above the yield plan density which results in an 18 lot density. The straight calculations for density per Article 6 result in a significantly higher yield.

We have met with the Conservation Commission and conducted a site walk in September. While we have not received any formal feedback we were left with the impression that our conceptual plans were received favorably by the Commission.

Following our Design Review meeting with the Planning Board in November we completed our final plan design. The proposed roadway is slightly less than 1000 feet in length. The second shorter roadway shown in the preliminary plans has been eliminated as have four lots resulting in a 14 lot subdivision with 75% of the parcel left as deed restricted open space. We do not anticipate that any waivers to the Subdivision Regulations will be required for this application.

We are confident that our plan complies with the "Purpose" section of the Conservation Development Ordinance and the general zoning requirements found in Article 6. We trust you and the Board will find the same and look forward to working with you and the Board through the approval process.
