## THE THREE SOCIOS: TIMELINE OF ACTIVITY

(July 12, 2016 through March 1, 2017)

## **EXPLANATION**

This timeline of activity is intended to respond to questions by the Barrington Planning Board about work since late July 2016 by The Three Socios, LLC, on the State permitting and satisfaction of conditions in its site plan application. It includes <u>only</u> activity relating to the state permitting and satisfaction of conditions in its site plan approval, most notably the design review approval condition. It does <u>not</u> include other activity related to the project, such as work with contractors and suppliers, construction details, project financing work, etc.

Because the submission of materials relating to each of these entries would create a substantial submission and because some of the entries represent preliminary submissions, private contracts, drafts and other documentation which underwent significant change during the course of work, such materials have not been attached. However, upon request by the Town of Barrington Planning Board, such materials can be produced, subject to protection of work product privilege and any reasonable explanations/objections if such materials are irrelevant to the remaining conditions of the site plan approval to be satisfied.

As discussed with the Town Planner, a separate submission identifying the outstanding State permits to be acquired, the status of those permits, and supporting documentation regarding those permits, will be submitted under separate cover during the week of March 20, 2017 or early in the week of March 27, 2017. That particular document will be updated as progress is achieved, so that the Planning Board remains abreast of work on those permits.
