SELECT BOARD MINUTES MONDAY, FEBRUARY 11, 2019

The Select Board meeting for Monday, February 11, 2019 started at 6:30 p.m. Present were Selectperson Ayer, Selectperson Hardekopf, Selectperson Hatch, Selectperson Knapp, Chairperson Bailey, Administrator Scruton and Deputy Town Administrator Maclver.

Chairperson Bailey welcomed everyone, reviewed his rules or order and led in the Pledge of Allegiance.

Chairperson Bailey opened the public hearing at 6:43 p.m. for the purchase of land for a turn around on Wildcat Road per RSA 41:14-a. An abutter has had constant concerns with vehicles turning around in front of his property. The town would like to purchase a small piece of land for the turn a round on the other side of the road at the purchase price of \$10,000. This is for snow plows and school busses. This is the last of two public hearings. There was no public comment. The hearing closed at 6:47p.m.

Police Command Staff Introduction – Deputy Chief George Joy and Lieutenant Katie O'Brien Chief Williams explained that George Joy is being promoted into the, newly created, Deputy Police Chief position. This is a realignment of supervision and not an addition of supervisory staff. Katie O'Brien is being promoted from Sergeant to Lieutenant. Chief Williams shared administrative and leadership accomplishments and emphasized their commitment to Barrington.

Hoyle, Tanner, and Associates – Construction Administration Contract – Mallego Road Bridge and Archaeology on Green Hill Road

Aaron Lachance and Jillian Semprini attended the meeting, representing Hoyle, Tanner, and Associates. Mr. Lachance made himself available for questions. Selectperson Ayer introduced Brian Lenzi to speak to the construction administration contract. Mr. Lenzi's concerns centered around the use of "observe" instead of "inspect". Mr. Lachance acknowledged the use of "observe" and explained it was for liability reasons, adding that the NH Department of Transportation (NHDOT) has already agreed to the language.

Selectperson Knapp raised concerns from the Young Road culvert project and with the complexity of the Mallego Bridge design. Mr. Lachance highlighted that it will be a part-time observation contract but will meet all NHDOT standards and specifications. This includes preparing all paperwork on behalf of the Town. Mr. Lachance acknowledged that the Young

Road culvert did not go as smoothly as they prefer their projects to go. Selectperson Knapp emphasized that issues and concerns raised by the Select Board should be addressed.

The Select Board discussed the details of the contract including; hours, length, photo documentation, and journal/daily notes.

Selectperson Knapp and Mr. Lachance discussed the design and high-skew angle. Mr. Lachance explained that the design is unique but is the most economical with lower structural and maintenance costs.

The Select Board discussed the archeological assessment for the Greenhill Bridge project. Based on the preliminary findings, an additional assessment is necessary and in compliance with NHDOT.

At 7:23pm Selectperson Hardekopf made a motion to enter non-public session pursuant to RSA 91-A:3 II a, c, d, or e for reputation. This motion was seconded by Selectperson Knapp and Chairperson Bailey asked for a roll call, Ayer – aye, Hardekopf – aye, Hatch – aye, Knapp – aye, Bailey – aye. The motion passes.

The Select Board reviewed the findings of the initial archeological review with Mr. Lachance.

AT 7:28 Selectperson Hardekopf made a motion to exit non-public. This motion was seconded by Selectperson Ayer and Chairperson Bailey asked for a roll call, Ayer – aye, Hardekopf – aye, Hatch – aye, Knapp – aye, Bailey – aye. The motion passes.

Selectperson Hardekopf made a motion to accept the updated proposal for archeological work on the Greenhill Road Bridge project. This motion was seconded by Chairperson Bailey and passed unanimously.

Selectperson Hardekopf made a motion to accept the construction administration agreement, contingent on state approval. This motion was seconded by Chairperson Bailey and passed 4-1 with Selectperson Ayer voting no.

Fire Chief, Rick Walker, said they would not be employees and explained that the labor attorney cited the FSLA "20% rule" which allows workers to earn 20% of a full-time employee before FSLA applies.

Selectperson Hardekopf and the Board discussed the number of call Fire and EMS individuals that would earn each level and differential. Selectperson Hardekopf acknowledged her amazement with the people who are willing to volunteer for this kind of work.

The Board requested the past two-year average for compensation to be compared to the proposed system.
