

### **BARRINGTON, NH SELECT BOARD MINUTES**

Monday, January 25<sup>th</sup>, 2021

The Select Board meeting for Monday, January 25<sup>th</sup>, 2021 began at 6:30 p.m. The meeting was held by remote participation via a Microsoft Teams Meeting due to the COVID-19 pandemic, in accordance with Emergency Order #12, pursuant to Executive Order 2020-04. In attendance were Chairperson Hardekopf, Vice-Chair Knapp, Selectperson Bailey, Selectperson Saccoccia, Selectperson Ayer, Town Administrator (TA) MacIver, and Municipal Office Administrator (MOA) Caudle.

### **OLD BUSINESS**

# **Mallego Engineering**

**6:41pm.** The Board previously approved drainage engineering work on Mallego Road, which referenced the Highway Layouts and Reestablishments budget line (01-4312-01-4344). That line has been consolidated into the Highway Consultants budget line (01-4311001-4349), and the funds will now be expended from the consultants line. No action was required by the Board.

## **Transfer Station Rules and Regulations Review**

**6:42pm.** The Select Board voted to approve the updated <u>Transfer Station and Recycling Center Rules and Regulations</u> at the January 4<sup>th</sup>, 2021 meeting. Erin Paradis, Transfer Station Administrator, shared the recommendation by the Transfer Station and Recycling Center Review Committee to require the sticker be affixed to a vehicle. Bob Lenzi, Transfer Station and Recycling Center Review Committee member, shared that he spoke with other New Hampshire municipalities with similar requirements. Vice-Chair Knapp shared his objection with the requirement to affix the sticker to the vehicle, citing <u>NH RSA 265:95</u> Obstruction to Driver's View or Riding Mechanism.

The Select Board agreed by consensus to request the Transfer Station and Recycling Center Committee reconsider options for sticker display.

**7:05pm.** TA MacIver will provide short scripts to Select Board members to introduce each warrant article. A <u>Frequently Asked Questions</u> document has been made available with additional information regarding Deliberative Session. Masks are required; however, for those who require ADA accommodation and are unable to wear masks, there will be a separate seating area and microphone.

# Request to Trade Land with Property Owner at 302 Smoke Street

**7:09pm.** Michael and Diane Flaherty previously approached the Select Board requesting to purchase one acre of Town land on Map 224, Lot 10, adjacent to their property, for \$2,000 to enable the construction of a pool on their land. After consideration and with the Planning Board's recommendation, the Select Board declined to sell the land. The Flaherty's have <u>amended their request</u> and would now like to perform a lot line adjustment and trade an equivalent area of land with the Town.

The Select Board agreed by consensus to not consider this request.

### **NEW BUSINESS**

### **Select Board Annual Report**

**7:11pm.** The Select Board publishes a report sharing what in the Town Report each year. The Select Board reviewed the written draft. Vice-Chair Knapp requested a change to the wording on renovation of the Highway Garage for safety concerns to "address operational flow" and requested clarification on additional revenue from the sale of properties. Chairperson Hardekopf requested a change to the wording to consider continuing virtual participation following the pandemic.

Selectperson Ayer requested consideration of an item in New Business, seconded by Selectperson Bailey.

# Canaan Back Road Nuisance Tree - Scenic Road

**7:15pm.** A resident on New Canaan Back Road has requested removal of a tree the Road Agent has declared a nuisance tree. As New Canaan Back Road is a <u>scenic road</u>, this <u>requires approval by the Select Board</u>. The tree is in the Town's right-of-way.

Motion to approve removal of the identified nuisance tree on New Canaan Back Road by Selectperson Bailey, seconded by Chairperson Hardekopf. Roll call vote: Ayer – No, Bailey – Aye, Knapp – No, Saccoccia – No, Hardekopf – Aye. *The motion failed*.

# **Financial Audit Award**

**7:26pm.** The Town has been working with Vachon Clukay, who offered a new audit team if the Town continues their contract as best practice is to have new individuals reviewing financials. After reviewing respondents, the recommendation is to consider <u>Vachon Clukay</u> or <u>Plodzik & Sanderson</u>.

Motion to award the Financial Audit contract to Plodzik & Sanderson by Chairperson Hardekopf, seconded by Vice-Chair Knapp. Roll call vote: Ayer – Aye, Bailey – Aye, Knapp – Aye, Saccoccia – Aye, Hardekopf – Aye. *The motion passed.* 

### <u>Public Safety Building Exhaust Ventilation Grant</u>

**7:32pm.** Fire Chief Rick Walker spoke to a need for increased ventilation at the Public Safety building for the diesel vehicles; this grant would require a 5% or \$5,000 grant. Vice-Chair Knapp requested the details on the prior application including equipment specifications, the cost of ongoing maintenance, monitoring that's been completed, etc.

Motion to approve the pursuit of the Exhaust Ventilation Grant, with the requirement that prior to any purchase there will be a full review of the maintenance cost and that the 5% match will come from the Fire Department budget by Chairperson Hardekopf, seconded by Selectperson Bailey. Roll call vote: Ayer – Aye, Bailey – Aye, Knapp – Aye, Saccoccia – Aye, Hardekopf – Aye. *The motion passed*.

## <u>Deliberative Session Request – Selectperson Ayer</u>

**7:46pm.** The Select Board agreed by consensus to enter through back entrance to the gymnasium at the Middle School for the Deliberative Session. There are parking spaces at the rear entry to allow parking that will not interfere with fire lanes.

## **SELECTPERSONS REPORT AND CONCERNS**

7:51pm.

**Selectperson Ayer** – Reported he has been unable to attend a School Board meeting due to difficulty with accessing the virtual meetings, the Town Lands Committee meeting was cancelled, and there was not enough activity to hold a Conservation Commission meeting.

**Selectperson Bailey** – Shared that the Zoning Board of Adjustment discussed two cases, one was approved, the second continued pending a walkthrough, which was completed on Saturday. The Library Trustees discussed possible alternates.

**Vice-Chair Knapp** – Was unable to attend the Planning Board meeting last week, no other meetings have been held. Engineering meetings are forthcoming.

**Selectperson Saccoccia** – The Recreation Commission now has added new members, the Recreation Department is planning for summer camp within COVID rules, and Administrative Assistant Erin O'Dea has just passed her first year work anniversary.

**Chairperson Hardekopf** – Had no additional information to report following the Transfer Station update.
