

## **BARRINGTON, NH SELECT BOARD MINUTES**

Monday, January 4th, 2021

The Select Board meeting for Monday, January 4<sup>th</sup>, 2021 began at 6:30 p.m. The meeting was held by remote participation via a Microsoft Teams Meeting due to the COVID-19 pandemic, in accordance with Emergency Order #12, pursuant to Executive Order 2020-04. In attendance were Chairperson Hardekopf, Vice-Chair Knapp, Selectperson Bailey, Selectperson Ayer, Selectperson Saccoccia, Town Administrator (TA) MacIver, Municipal Office Administrator (MOA) Caudle.

**6:30pm**. The meeting was called to order by Chairperson Hardekopf.

#### RSA 91-A EMERGENCY PROVISIONS/SELECT BOARD CHAIR EMERGENCY DETERMINATION

**6:30pm.** Chairperson Hardekopf read the emergency provisions of the State of Emergency and explained how this meeting is accessible as well as how to access future meetings.

**6:32pm.** Select Board attendance was taken via Roll Call: Ayer – Present, Bailey – Present, Saccoccia – Present, Knapp – Present, Hardekopf - Present. Each Select Board member shared their location and stated that at present, they were alone in their respective rooms with no one influencing their votes.

## **PUBLIC HEARINGS**

#### **2021 Proposed Operating Budget**

6:34pm. Pursuant to RSA 32:5, I and V; RSA 40:13, II-a (c)

Town Administrator MacIver presented the 2021 Municipal Operating Budget Proposal and Warrant Articles, including a review of the Unassigned Fund Balance, funding sources, and significant changes to the budget. He also shared that there is currently a 3.5% tax delinquency rate, lower than average. The Select Board committed to fund an additional \$175,000 in 2021 from the Transportation Fee Capital Reserve Account, which is funded by \$5 from each registration for additional paving projects. The petitioner also agreed to this change if the language must be changed.

# <u>Issuance of Building Permit on Berry River Road for James Maravelias and Sarah Battiato</u>

**7:11pm.** Department Heads and the Planning Board recommend the following requirements:

- 1. Take care to grade the property frontage away from the road to prevent water runoff being directed onto the road.
- 2. Add 15-inch culvert under the driveway near the house.
- 3. Do not build up grades within 10 feet of the side property boundaries so no new runoff is directed onto abutting property.
- 4. Upon completion of construction, the road in front of the property should be graded to correct any rutting incidental to the construction.
- 5. Join the local Road Association.

Jack Gale, Abutter, shared his concerns about the lot being able to support the building process and setback requirements. Code Enforcement Officer/Building Inspector John Huckins confirmed that all required permits have been secured from the State and the property is able to meet all Town requirements.

Motion to authorize the issuance of a building permit for Map 104, Lot 56 with the above conditions by Vice-Chair Knapp seconded by Selectperson Ayer. Roll Call vote: Ayer – Aye, Bailey – Aye, Knapp – Aye, Saccoccia – Aye, Hardekopf – Aye. *The motion passed.*

The Transfer Station and Recycling Center Review Committee has been reviewing and updating policies and procedures, prices, and costs to make updated recommendations to the Town and Select Board.

**Selectperson Ayer** - spoke to the growth of demand for recycled materials in neighboring states. Chairperson Hardekopf encouraged Selectperson Ayer to bring that information to the Committee.
