2022 TAX RATE & TOWN UPDATES

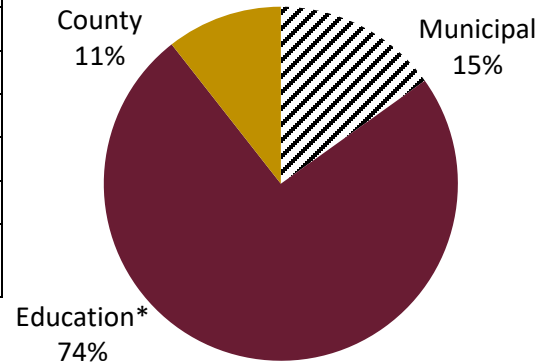
November 10, 2022

Barrington's 2022 property tax rate is **\$19.85** per \$1,000 of assessed value. The tax rate by jurisdiction is: \$14.75 for Education*, \$3.00 for Municipal, and \$2.10 for County. Your enclosed tax bill will reflect the 2022 tax rate and tax responsibility (minus first bill/other 2022 payments) based on the assessed value of your property as of April 1, 2022.

NOTES FROM TOWN OFFICES

Town Clerk's Office - All dogs are to be licensed in New Hampshire by April 30th of every year per RSA 466:1. Failure to license your dog by June 1 may subject the owner to fines and a court summons. Beginning June 1 late charges are assessed at \$1.00 per month, per dog, as well as the original licensing fees. Civil forfeiture fines will also be assessed in the amount of \$25.00 per dog plus a \$7.00 service fee. **IF YOU NO LONGER OWN YOUR DOG**, contact the Town Clerk's Office at (603) 664-5476, and your record will be updated so you do not receive any further notices for the dog(s) you no longer own.

Residents can license their dog(s) for the year with proof of:

- Current rabies vaccination certificate
- Spaying/Neutering certificate
- **\$7.50**: Spayed/Neutered and dogs under 7 months old
- **\$10.00**: Dog(s) that are not spayed or neutered and older than 7 months
- **\$3.00**: Residents who are 65 years old by January 1 of the current year may register **one** dog at this rate

Residents may mail copies of certificates along with a check made out to: **Barrington Town Clerk**

Tax Office & Assessing - If you need assistance with future property tax bills, some property owners are eligible for Tax Credits or Exemptions. Information about available credits and exemptions as well as applications can be found on the Town's website (www.barrington.nh.gov) or by calling the Town Hall at (603) 664-9007. Below is a listing of exemptions, credits, and other property tax reductions currently offered in the Town of Barrington:

- All Veteran's Credit (\$650)
- Surviving Spouse Credit (\$2,000)
 - Surviving spouse of a resident who suffered a service-related death
- Service-Connected Total Disability Credit (\$3,550)
- Elderly Exemption (\$85,000-\$161,500 age-based)
 - Income Limit
 - Single \$36,000
 - Married \$50,000
 - Asset Limit (does not include primary residence)
 - Single/Married \$125,000
- Blind Exemption (\$15,000)
- Solar Exemption (added assessed value)
- Current Use (parcels larger than 10 acres)
- Disability Exemption (\$50,000)
 - Income Limit
 - Single \$30,000
 - Married \$50,000
 - Asset Limit (does not include primary residence)
 - Single/Married \$75,000
