## MINUTES – COMBINED TRUSTEE & BUILDING COMMITTEE MEETING - draft BARRINGTON PUBLIC LIBRARY OCTOBER 25, 2023 – 5:30-7:05

- 1. Jason presented the budget for the purchase and conversion of the "MOB (medical office building) to the BPL.
  - Cost estimates are for construction to begin in the fall of 2024, so include inflation estimates.
  - Cost estimates are for the "upper middle" of the quality range (where SMP & Bauen usually start), with the axiom that one can reduce costs after a bond but cannot increase costs.
  - The \$1.1 M land purchase is the current asking price. In a note from Rob Gibson Conner MacIver has indicated that the real estate attorney submitted an offer on behalf
    of the town last week awaiting a response. No details given. Closing costs are not
    included in the budget.
  - Soft costs owner contingency at \$250,000 is conservative, but is generally less for a renovation than new construction. This acts as a "safety buffer" for the owner if changes are made during the course of the project or unexpected conditions arise.
  - Construction costs at \$1.7+ M
    - o derived from cost estimates from subcontractors used by Bauen.
    - Additional costs for re-shingling the roof and complete replacement of the HVAC are offered d/t the ~23 year age of the building, but do not reflect expert input from anyone at the time. Further input from experts in various aspects of building structure / operation was recommended and will be obtained during the building inspection to be done once a P&S is signed.
    - Jesse will obtain maintenance information from HVAC vendor that installed the system; Susan will seek more information on last ~2 years of energy costs for this building
  - Solar panels/ energy efficiency
    - no cost estimates provided (see minutes from last meeting) Jack Bingham of Seacoast Energy Alternatives will be consulted by Susan.
    - EBSCO Solar also offers a grant of \$60K to public libraries this will be submitted after 3/12/24 voting.
    - Windows are good quality and in good shape, do not need replacement.
    - Wall and ceiling insulation has not been assessed. Ceilings will be raised in some but not all areas.
    - All lighting will be changed to LED.
  - FFE costs often paid for from left over "owner contingency"
  - Recommended as part of a signed agreement, all medically-related hardware, including the radiology equipment / lead walls need to be removed at seller's expense.
