Sand RFP: This is for approval of the text. Incidentally I do not see that it makes any sense to put this in the newspaper given the cost and low results (only 2 for Pavement Marking). I propose sending to those who have proposed in the past and others we know about in the area. (See proposed RFP at end of report). *Does the Board wish to send this out?*

Old Settler's Road bridge engineering: The state has agreed to 80% funding and accepted the HTA proposal for preliminary engineering. The Bridge Capital Reserve Fund has \$250,000. The Town has to expend the funds and then will be reimbursed when the bridge is finished. *Will the Board authorize entering an agreement for \$120,476 and request the Trustees of the Trust Fund provide payment of up to \$120,476 for this engineering from Fund # 63 Bridge & Culvert Capital Reserve Fund?*

Authorization to advertise for sealed bid Map 104 Lot 89 on Berry River Road 0.16 acres. Steep topo, boulders. Abutter's realtor asked. *Will the Board authorize to advertise lot?*

Date of Next Meeting. *Given the extended meeting planned with the attorney for August 20, does the Board wish to add a regular meeting August 13?*

Potential Appeal of waiver of Noise Ordinance. A wedding is planned for July 28 at 702 Scruton Pond Road with a band that will go past 9 PM. I am granting the waiver and people can appeal to the Board at this meeting. As of this writing we have not had an appeal.

Town of Barrington Request for Proposal Winter Sand

The Town of Barrington is seeking proposals for purchasing 4,000 yards of winter sand. Sand to be free of overburden and clean and no larger than 3/8" diameter of stone. Sand may be inspected prior to acceptance of bid and at any time the Town desires while in the purchasing process. The Road Agent must approve of the sand for the bid to be accepted. All bids must include delivery at the Town's Highway Dept. on 226 Smoke Street. Bids will be opened July 23, 2018 and if a decision is made by the board, Delivery can start immediately. All sand should be delivered by October 31, 2018.
