Fire Chief: Labor attorney indicates 2 hour minimum not required by state or federal law for our firefighters whether they are stipend or not unless required by town policy. Rick would like to implement a new staff scale for what are call-firefighters/part-time firefighters. **Does the Board approve these changes?**

Information

Cost for Beauty Hill Road Improvements: We have three estimates from Dubois and King. \$334,500 called preservation; \$554,800 for Reclaim and Pave; and \$976,300 for rehabilitation. None of these options have been budgeted.

Cost for bike trail The estimated cost of doing a mile of trail per standards as requested of Dubois and King was \$529,500.
