The unit consists of single rear axle dump truck with front plow and single wing with steel dump body and stainless steel sander. The Town is requesting pricing to provide and install equipment specified. Costs will not be the sole factor in awarding this request for bid, functionality, operating cost and vendor proximity will be a consideration as well.
