

IMPORTANT DATES AND DEADLINES

Town Elections are always held on the 2nd Tuesday in March.

Tax Bills are typically mailed in May and November.

Tax Abatement Form is due by March 1st.

<u>Tax Credit or Exemption Form</u> is due by April 15th. (Includes Veteran Tax Credit, Elderly, Disabled and Solar Tax Exemptions.)

Tax Deferral Form for Elderly and Disabled is due March 1st.

Current Use Application Form is due by April 15th.

Report of Wood or Timber Cut is due by May 15th.

Dogs must be licensed no later than April 30th.
