Public hearing on Highway funds to accept and expend unanticipated funds, \$185,620.26 from NHDOT for highway purposes as outlined in NHDOT letter. This can be used for equipment fully dedicated to highway maintenance, work on highways and work on bridges. It can be spent in 2018 without further action needed by Town Meeting. Will the Board vote to accept the funds? Does the Board have a plan on who to expend the funds?

Public Hearing for Acceptance of Grant and Authorization to Expend for mutual aid air truck Community Mutual Aid District, of which we are a member, was awarded a \$220,000 grant to purchase a new Air van/Rehab unit. Barrington was the sponsor for the grant. Will the Board vote to accept and expend the grant?

**Public Hearing regarding Parking Ordinance:** The Conservation Commission recommends "No Parking from Dusk to Dawn" on the Goodwill conservation property and the two parking areas on SATWASR (Tamposi). They have voted to buy the signs with their funds. *Will the Board of Selectmen concur and vote to prohibit parking dusk to dawn on the Goodwill conservation property and the two parking areas on SATWASR?* 

Conservation: Hart/Moroukian Property. What does the Board wish to do?

**MEETING WITH ABC TO REVIEW REVENUE/EXPENDITURE PROJECTIONS:** Current revenue is running ahead of projections. I anticipate by year end that we will be about \$130,000 above the budget projection in January of this year. I will include that increase in the MS-4 that I file with the state to set the tax rate.

**Library President of Board wrote**: As you are no doubt aware, the library Board of Trustees, coupled with a few dedicated volunteers set up a 501(c)3 non-profit in 2016, known as the Barrington Library Foundation. The Foundation and its subsequent Campaign Council are becoming very active now. As such, the trustees would like to introduce the Foundation to the Board of Selectmen.

The Barrington Library Foundation and Campaign Council, along with the Library Trustees,

invite the Barrington Selectmen to participate in a work session in order that the Council can present an update to the Selectmen on the history of the efforts to create a new Library, our current plans, and the need to obtain Selectmen consideration and approval of several ongoing issues (to be put forward and voted on at the following Selectmen's meeting). This work session is open to the public, but is informational only and will not be open to public comment.

We would request the Board of Selectmen's presence on Tuesday September 26th at 6:00 PM at the library. Please put this in front of the board for their consideration.

**Fire Department Pick-up:** After reviewing all of the specifications and desired options Rick determined that the 2017 Ford was almost the same as the 2018 Dodge, and recommends the Town go with the Dodge since it is a year newer. **Does the Board support purchase of the Dodge instead of the Ford?** 

Old Business: Selection of attorney for labor issues including Collective Bargaining.

## Information:

**Town Clerk:** State is going to try its update on Motor Vehicles state wide again. Last time it failed and had to be reversed. The schedule is October 6-10. The only day we would have been open is 10/10, but we will be closed that day. We open late on Wednesday normally and that opening would be conditional on the program working by the time to open.

Assessment: Total Net Valuation (accounting for exemptions, etc.) increased \$76,624,813 or 8.3%
