Chestnut open space: John Wallace on the proposed policy: It would include language to allow the town to install a well. It would conform to the proposed land use plans of the Conservation Commission (see at end of this report). **What does the Board wish to do?**

Selectmen informational flier reminding people to vote at Town Meeting. Discussion on content and distribution. The School Board will meet February 16 and discuss sending out a joint discussion of issues as we did before last year. **What does the Board wish to do?**

Demolition, S&R Construction. We have the bill for finishing the demolition clean-up. It is for \$190,000, the amount the Board of Selectmen agreed to pay for change order 1 and the original contract. Mike Clark has been in contact with S&R regarding the tonnage coming in much lower than estimated. **Shall the town pay it?**

Clarification: The Trustees of the Trust Funds want a clear motion to indicate that the Board of Selectmen intended to take the \$122,000 for the Loader last summer out of the Highway Heavy Equipment Capital Reserve and that the Board is using \$34,999 from the Emergency Communications Capital Reserve for the fire repeater tower. **Does the Board wish to make that motion?**

Lee Class VI Road: The town of Lee questions what the damages will be for the town in closing off the road through to Route 4. *How does the Board wish to respond?*

PUBLIC USE OF TOWN-OWNED CONSERVATION LANDS:

Established to protect the natural resources of Barrington's town-owned conservation lands, the following public usage policy applies:

- Allowed uses include passive recreational activities such as hiking, snowshoeing, cross-country skiing, fishing and hunting.
- Mountain biking and horseback riding are allowed unless specifically prohibited and posted on particular trails. Please stay on the trails and be careful in sensitive and wet areas to prevent erosion and damage to the trail.
- Not allowed are motorized vehicles of any kind except for snowmobiles on designated trails in the winter months. Trails open to snowmobiles will be determined in partnership between the Barrington Snow Goers Club and the Barrington Trails Committee.
