

**Public Hearing** The Board of Selectmen will hold public hearings on a land swap of commercial land adjacent to Liberty Truck per RSA 41:14-a at the ECLC 77 Ramsdell Lane at 6:30 pm on July 11, 2016 with an anticipated vote on the matter July 25, 2016. This will involve a 4-5 acre subdivided off the 125 acre Town commercial lot (263-13.1) to be exchanged for the 7 acre parcel also adjacent to Liberty Truck (263-19).
